Overview

Board certified construction law counselor and advocate, Aaron Reichelson, prosecutes and defends construction-related claims in state and federal courts across Florida and beyond. Prior to the law, Aaron had a 15-year career in the construction industry, including 13 years as a Project Engineer/Contract Administrator for Kiewit, and two years as a consulting engineer on scheduling and dispute resolution matters for many of the industry's largest contractors. Aaron's front-line experience provided him with a foundational understanding of both the technical and business considerations his client's face daily. This experience supports his understanding of his client's "bigger picture" objectives. Aaron is personally committed to identifying potential problems and recognizing obstacles to progress so that such issues do not snowball into roadblocks down the line. Having worked on the business side for more than a decade, Aaron still enjoys getting his boots dirty on a jobsite and it makes his day when his clients recognize that he "speaks their same language."

Aaron currently serves as an adjunct professor of construction law at Stetson Law School. He joined the ABA Forum on Construction Law in 2015 and was selected to the Division 5 steering committee in 2019. Aaron is also active in the Dispute Resolution Board Foundation, both as a DB member on a large airport project as well as supporting clients on other projects with DBs. Other industry participation includes the Florida Transportation Builder's Association, where Aaron has provided consultation on proposed FDOT specification changes and other construction law topics.
