## Overview

In addition to serving on Stetson's Law Review, Audrey was a teacher's assistant where she tutored students in arbitration skills, persuasive legal writing, and arbitral law.

Prior to joining Gunster, Audrey received her bachelor and master of science degrees in strategic communication studies from Florida Tech. Her master's thesis on political branding was published in 2020 at the International Communication Association's 70th Annual Conference.
